ADDITONAL LOCAL RULES – GAMLE FREDRIKSTAD OPEN 2024



A-4 Internal Out of Bounds

During play of hole 6, a ball that is lying on or have passed fairway on hole 9, defined by the edge of the general area cut to fairway height or less, is out of bounds. This edge is boundary edge during play of hole 6

B-1 Defining Penalty Areas

Unmarked ditches

Unmarked ditches are defined as red penalty areas. The edge of the penalty area is defined by the natural limits of the penalty area, i.e., where the ground breaks down to form the depression containing the water.

Penalty Areas (Rule 17)

Red Penalty areas marked with red paint on hole 5 and 18 (right hand side), hole 6, 7, 16 and 17 (left hand side) are defined on only one side and extends to infinity.

E-3 Preferred Lies

When any part of a player's ball touches part of the general area cut to fairway height or less, the player may take free relief once by placing the original ball or another ball in and playing it from this relief area:

- Reference Point: Spot of the original ball.
- <u>Size of Relief Area Measured from Reference Point</u>: One club-length from the reference point, **but** with these limits:
- Limits on Location of Relief Area:
 - o Must not be nearer the hole than the reference point, and
 - Must be in the general area.

In proceeding under this Local Rule, the player must choose a spot to place the ball and use the procedures for replacing a ball under Rules 14.2b(2) and 14.2e. **But** for the purposes of applying Rule 14.2e, the player has only chosen the spot on which to place the ball once the ball has been set down, and the player has let the ball go with the intent for that ball to be in play. After a ball has been placed and is in play under this Local Rule, if the player then proceeds under another Rule that provides relief, this Local Rule may be used again.

F-1 Defining Abnormal Course Conditions and Integral Objects

Abnormal Course Conditions (including Immovable Obstructions) (Rule 16)

Integral Objects

Retaining artificial walls

F-5 Immovable Obstructions Close to Putting Greens

Relief from interference by an immovable obstruction may be taken under Rule 16.1. The player has an extra option to take relief when such immovable obstructions are on or close to the putting green and on the line of play: <u>Ball in General Area</u>. The player may take relief under Rule 16.1b if an immovable obstruction is:

- On the line of play, and is:
 - o On or within two club-lengths of the putting green, and
 - o Within two club-lengths of the ball.

But complete relief must be taken, which includes both physical and line of play interference. **Exception** – **No Relief If Line of Play Clearly Unreasonable.** There is no relief under this Local Rule if the player chooses a line of play that is clearly unreasonable.
